# Information required when applying for Child Care Fee Subsidy:

### **Income Verification**

- Recent Notice of Assessment (NOA) from CRA account pages 1 and 2 must be submitted
- Canada Child Benefit (CCB) notice from CRA account pages 1 and 2 must be submitted

### The following if applicable

- OSAP information (Ontario Student Assistance Program)
- Confirmation of school enrolment
- Ontario Works/ Ontario Disability confirmation
- Current paystubs
- Letter of employment if paystub is not available
- If Self-employed, self-employment package completed

#### Verification of Identification

• Social Insurance Number

### Referral

• If you are applying based on a referral, we require **2 letters of support** from a current service provider or medical professional.

## Custody

- Parents who are separated/single are required to sign a "Declaration of Separation" form
- Custody agreement if available
- Child Care Benefit notice (CCB)

### **Eligible Hours of Care**

• Work/school timetable that lists days and hours required to be in school or at work
