Recommendation:

The Long Term Care Information Report dated September 7, 2017 is for information.

Background:

Respiratory Outbreak at Brucelea Haven

The outbreak at Brucelea Haven was declared over on July 19th. Since that time the Brucelea Haven management team have been working diligently to collect staff observations and suggestions regarding the facilities response to the summer's outbreak. Working in collaboration with Public Health, new protocols and procedures are being developed based on lessons learned. These new processes will improve future outbreak management responses and mitigate the effects of a virus in a Home. A revised communication pathway has already been developed and implemented to ensure consistent management of these complicated cases when they are first suspected.

150th Celebrations

Since July 1, 2017, residents from both homes have been 'virtually' walking the Bruce Trail in recognition of Bruce County's 150 anniversary. Collaboratively we are over half way on our walk, according to our map, we are in Kincardine as of July 12. Residents from both homes met at McGregor Point to continue their walk outdoors. Brucelea Haven's 150th celebration event day has yet to be determined.

Centralized Scheduling

The design and implementation of a centralized scheduling process for the two County homes and paramedic services is underway. The County's Policy and Planning team were engaged for a process review, stakeholder meetings and to develop a full GANTT chart to guide implementation the various phases of this project. The initial staffing model has changed in



order to ensure effective training, consistent coordination and workload management are the primary focus of the plans execution.

The Centralized Scheduling position was posted internally and externally. This posting will close in late August.

Lean Process

Both homes are participating in Lean process workshops along with all County departments to support a culture of improvement and collaboration.
